No exceptions.</p>	<p>02 - DISCIPLINE</p> <p>AUTHORIZED RESELLER ONLY</p> <p><i>"Where it goes is where it stays."</i></p> <p>When granted authorization, we operate as the designated reseller and never transship, divert, or sell to other unauthorized sellers.</p>	<p>03 - PRICING</p> <p>MAP COMPLIANCE</p> <p><i>"Your price floor is our price floor."</i></p> <p>All advertised pricing complies with the brand's Minimum Advertised Price.
